Founding memberships are transferable and retain all original founding member rights. The sale of the transfer does not qualify for the Non-profit tax donation, and all rights held by selling owner are discontinued, to include current nominated stallions.

The founding member payment plan may be utilized, with payments of \$20,000.00 at time of signing, \$15,000.00 for the following year due on June 1 and \$10,000.00 due on June 1 of the third year.
